

# Eurocamp Residential Basketball Camps

---

## Booking Terms and Conditions

In relation to this entire document, Eurocamp shall be deemed to mean **Eurocamp Residential Basketball Camp held in Dundee, Barrow in Furness and Portsmouth.**

1. By asking us to accept and confirm your booking, you are entering into a contract with Eurocamp and are accepting the terms and conditions set out below.
2. All bookings will not be considered confirmed until we receive a fully completed booking form for each camper and a deposit of £70.00 per camper.
3. Bookings made under our Early Bird Offer will be confirmed only until such time as the remainder of the full deposit is due, usually the 31<sup>st</sup> January in the year of the camp being booked. Once that date is reached, the remaining deposit amount must have been received by Eurocamp. We reserve the right to cancel any bookings where the full deposit has not been received by the due date.
4. All deposits are non-refundable. In respect of Low Deposits, you are obliged to pay Eurocamp the full deposit amount of £70 immediately if you cancel your booking. If you choose not to, Eurocamp reserves the right to proceed against you for recovery of the outstanding balance.
- 5. WE STRONGLY ADVISE ALL CAMPERS TO TAKE OUT THEIR OWN INSURANCE AGAINST CANCELLATION THROUGH INJURY OR ANY OTHER REASON. IF YOU DO NOT, YOU UNDERSTAND THAT THIS IS AT YOUR OWN RISK AND COST.**
6. If you choose to book and pay for your camp place using the monthly payment scheme, the first £70.00 that you pay will be considered your deposit.
7. The date for final payments to be received will be different for each camp. We will advise you of the due date for each camp. Eurocamp reserves the right to cancel any bookings without refund, where the balance has not been paid in full by this date.
8. All new bookings made between 1<sup>st</sup> July and the first day of camp must be paid in full at the time of booking.
9. Eurocamp will consider altering/amending or transferring deposits between campers but we are not obliged to do so. Where we agree to do this, an admin fee of £25.00 will be charged, which you agree to pay.
- 10. DEPOSIT PAYMENTS ARE NON - REFUNDABLE. BALANCE PAYMENTS ALSO BECOME NON – REFUNDABLE IF A BOOKING IS CANCELLED WITHIN ONE CALENDER MONTH OF THE OFFICIAL CAMP OPENING.**
11. In the event that we cancel Eurocamp, all monies paid will be refunded.
12. Eurocamp accept the following methods of payment:
  - a) Cash – GBP Sterling only. Cash sent to us in the post is sent entirely at the senders risk.
  - b) Personal or Bank Cheques made out to “Eurohoops Basketball”

- c) Online via our website [www.eurocampsbasketball.co.uk](http://www.eurocampsbasketball.co.uk) These payments are handled on our behalf by Paypal but you do not require a Paypal account. Credit and debit cards are accepted. We agree to pay all Paypal fees incurred.
- d) Bank Transfer (ask for details)
- e) Paypal Invoice, please ask us to send one.

13. We will usually communicate with you by E Mail or post using the information you give us at the time of booking. It is your responsibility to notify us in writing of any changes to these details. Eurocamp will not be held responsible for any issues arising from you failing to notify us of any changes.

### Cancellation Policy

1. All deposits are non-refundable. In respect of Low Deposits, you are obliged to pay Eurocamp the full deposit amount of £70 immediately if you cancel your booking. If you choose not to, Eurocamp reserves the right to proceed against you for recovery of the outstanding balance.

**2. DEPOSIT PAYMENTS ARE NON - REFUNDABLE. BALANCE PAYMENTS ALSO BECOME NON – REFUNDABLE IF A BOOKING IS CANCELLED FROM WITHIN ONE CALENDER MONTH OF THE CAMP START DATE.**

### Distance Selling

For all online bookings, you have a “cooling off period” of 7 working days from the point where you enter into a contract with us to provide a place at Eurocamp. We consider you to have entered into a contract with us when we have received either a completed booking form and/or a deposit for the provision of our services and we have confirmed receipt of it by E Mail or letter to the E Mail or postal address provided to us by you.

If you wish to cancel your booking within the 7 working day period, you may do so and all monies paid will be refunded. However, you must notify us in writing of your wish to cancel.
